In the event the undersigned becomes delinquent for more than 25 days in the payment of the monthly service charge, the District may: shut off service without notice or liability; take legal action to collect all delinquent service charges together with a turnoff fee and interest at the maximum legal rate; or certify any delinquent service charge, penalty and interest to the Salt Lake County Treasurer for collection by the County with ad valorem taxes, and undersigned will pay the reasonable cost (whether suit is filed or not) of collecting the arrearages, including a reasonable attorney's fee and the lawfully established monthly rates as may from time to time be established by the Board of Trustees of said District.

6. The District and the Water System Operator shall not be liable for damages, nor will allowances be made for loss of production, sales, revenue, or service, in case of water pressure variation, or in case the operation of the District's source of water supply or means of distribution fails, or is curtailed, suspended, diminished, or interrupted for any cause. Such pressure variations, failure, curtailment, diminishment, suspension, interruption, or interference shall not be held to constitute a breach of contract on the part of the District or in any way affect any liability for payment for any charges or assessments due.
